SUBJECT: POLICY 450: STUDENT SURVEYS (FIRST READING)

RECOMMENDATION:

It is the Administration's recommendation that the School Board approve on First Reading, the revisions to School Board Policy #450, section D, of the *Student Rights and Responsibilities* document, as shown on Attachment A.

PERTINENT FACTS:

The first session of the 21st Legislature approved House Bill 70 relating to the use of Student Surveys in the public schools of Alaska. This legislation was approved by both houses of the Legislature during the just-completed session, and signed by the Governor on June 22, 1999. The law takes effect on September 20, 1999.

The School Board and the District supported this legislation as it clarified the intent of previous State Law (AS 14.03.110) relating to surveys. The previous law caused difficulties for the District as there were two conflicting Attorney General's opinions as to the legality of using anonymous surveys which inquired into private family affairs without acquiring prior parental consent as required by both state and federal laws relating to privacy.

The Administration and the District's legal counsel felt that the ambiguity caused by the conflicting legal opinions would potentially set the District up for a lawsuit; thus the District did not support the use of surveys such as the Youth

Risk Behavior Survey and others of this type without actively soliciting written consent from the parents/legal guardians of the students.

These changes in the law will give the District guidance in using surveys which inquire into personal or private family affairs in the future. Annual and two week advance written notice are now required prior to the use of any surveys which inquire into personal or private family affairs of the student not a matter of public record or subject to public observation. Parents/legal guardians will have the right to review any surveys to be used prior to the administration of the survey.

The Administration and District legal counsel proposed revisions to the current policy to bring it into conformance with the new statute, AS 14.03.110, so that guidance on the use of surveys can be given to principals and supervisors at the beginning of the 1999-2000 school year. These proposed revisions were taken to the School Board Policy Sub-Committee on July 22, 1999, and with a minor modification, passed out of committee unanimously to the full School Board for action.

Once the second and final reading are completed, the Administration will provide information to all parents/legal guardians, students, and school and program administrators for implementation at the beginning of the 1999-2000 school year. Information will be included in all beginning of school year publications and information; forms will be available at the schools and through school newsletters. Once revised, Policy 450 (D) will be included with the *Student Rights and Responsibilities* documents widely distributed to students and staff and parents.
