Transition services are addressed in the IEP (Individualized Education Program) starting at age 15, to implement services by the age of 16. Transition services are provided to prepare the student for life after secondary education. Successful transition can be achieved through a team effort involving the student, parents, school staff, and community resources.

ACT is a postsecondary community-based instructional program for adult students (18 to 21 years old) needing additional transitional support after completing the required core credits at their neighborhood school. It provides a supportive work environment to develop work maturity skills. Other areas of instruction are daily living, communication skills, and recreation and leisure. Project SEARCH provides students with disabilities an opportunity to transition from high school into a work internship. The goal of this structured one year program is to assist students in obtaining paid employment upon completion. The application process takes place in the winter for students between the ages of 18-22 with an IEP. College Admission Tests

ACT is a standardized test used for admission to college. It covers four academic skills; English, math, reading, and science reasoning. ACT provides accommodations for students with documented disabilities though, advance approval is required. Practice tests are available online. SAT is a standardized test used for college admissions. The skills

tested are writing, critical reading, and math. The SAT is administered seven times per year, and provides practice tests online. FAFSA (Free Application for Federal Student Aid)

Completing the FAFSA is necessary for students to receive grants, loans, and scholarships for most colleges and technical schools. Accessing Accommodations at Postsecondary Schools

Requesting accommodations is a voluntary student responsibility. They will need to inquire at the school's Disability Support Service Department and provide documentation.
