I don't think I've ever seen one where there is subcommittees and all their tasks underneath. Because if you know if your on the fundraising committee you have to raise funds. Roger H. Martha I really appreciate you as identifying and saying what you just said because there is clearly some confusion on how that is supposed to work and I am glad you mentioned what most everyone else thought, thank you. Manny A. I've been scheduling subcommittee meetings for the last year being the chair of the fundraising subcommittee without the permission of the APC just deeming it part of the roles and responsibilities of the fundraising subcommittee and I've never been questioned about it. Martha G-L. No and you shouldn't be the subcommittees can't wait for the APC to give the permission to meet. Manny A. exactly. I have the by-laws up right now it's a really tiny section on committees and I can share it with you to show you where this is coming from but also how we are going to fix it. Martha G-L. I think where it kind of fell apart is whoever took the notes for the subcommittee didn't really send it out. Manny A. shared by-laws: Committees section. Section II is what forced me to have an APC meeting tonight. Instead of a strategic planning committee because I was told that the strategic planning committee was not specifically tasked with the Abbott Loop Survey by the APC. I want to get two things out of this committee meeting first that we get a survey out of this meeting and two that something like this doesn't happen again. That we have something in our by-laws that shows a brief description of our subcommittees and what they can do. I created a short word doc with a general brief description of what of what the committees do. Martha G-L. I would add elections and recruitment. Manny A. there is a section in our by-laws for elections and principal evaluation/contract. They are the only subcommittee taskings in our by-laws. Marge W. the building subcommittee seems like it would be over the topic and if this should have been under the building subcommittee if this should have been under the building subcommittee rather than strategic planning. Martha G-L. I'm wondering because we tried to stay generic I'm wondering if we should just do the top part the duties and responsibilities of committees. And if your in one of the committees' come up what you commitment is for now because it will change over time. Manny A. I agree and am fine with that. Martha G-L. let the committees come up with what their tasked for and what they need to bring to the next board meeting and we are moving forward in this direction. Manny A. this is also to in for FOANCCS and it is in the beginning stages. Martha G-L. what I am saying is that we should keep what is at the top. Christine H. for Friends we don't need the specifics listed below it's just more about how often are you meeting and it stemmed from the building committee not meeting for several months and we wanted to be more involved. I think that is something that can be remedied as we go. Manny A. this is just something I quickly put together, it's an example. Martha G-L. each committee should have a task in front of them that they know they are doing. I'm steering away from putting in the by-laws because you are always going to be changing the by-laws. Manny A. we need to have something in their because right now there is nothing. Martha G-L. I like this top part and we can amend the section to read differently so subcommittees really do have the power

to act as they need. Roger H. agreed but doesn't know how to address the issue that Manny A. encountered unless we go over at the next APC meeting what the wholistic philosophies of the subcommittees so that this issue (not being able to call a subcommittee meeting) doesn't occur again. Because one person has prevented Manny A. from moving on because of one random line in the by-laws. Martha G-L. that was never the intent. The work must be done on committees this school wouldn't have gotten started if we had to do everything. The committee was tasked with doing a certain thing and they did it. Manny A. I like your idea of keeping it general and broad but it is something that needs to be done. Martha G-L. we must amend the by-laws: Section II to allow the subcommittees to do their work. Requires public posting. Sometimes we have very literal people that stop the work when it can't stop. Michael P. what is the earliest that we can vote on amending the by-laws? Manny A. the board would have to be presented with something whatever is going to be amended in the by-laws. The board would then edit if needed and it would have to be voted on and it must be posted to the public for 60 days. Martha G-L. we need to add a vote tonight. Manny A. we can add a vote to task the by-law committee to implement a change to present to the board. Martha G-L. to clarify tonight would like the board to vote on Section II of the bylaws to empower the committees and the chairmen's of the committees to move ahead on what the tasks of the committees are and then we would also like to activate the by-laws committee to complete the task. Martha G-L. I make a motion to rewrite Section II of the committees of by-laws to designate subcommittees to move ahead as tasked to the committee and as designated by the committee title. Michael P. I think I would separate. I would say a motion to amend the committee by-laws and yes or no. And then another motion to task the subcommittees to writing or basically structuring themselves in certain ways. Martha G-L. I agree and makes motion to rewrite Section II of the by-laws. Seconded by Pamela D. Roll-Call Vote motion passed unanimously. Martha G-L. makes a motion to authorize subcommittees to move ahead with their committee tasks and call meetings as seen fit to move ahead and accomplish their tasks of their committee. Manny A. can I get a second. Roger H. seconds. Vote taken Pamela D. votes no Roger H. yes Caroline W. uh Martha G-L. do we need more discussion. Pamela D. yes because we will run into the same problem with the word "tasks" aren't we just trying to say that we give the subcommittees our blessing to move forward with the work that they do? Roger H. yes that is exactly what we are trying to say so we don't run into the same issues. We are doing this overarching statement saying that the committees can do what is needed without being tasked. Pamela D. if you look in the comment box you will see something Christine H. put in and it makes sense. Martha G-L. that's right. Ronni W. we need to either back up and get out of this vote or continue the vote and come up with another motion. Manny A. right now there is a motion, Martha G-L. I am going to withdraw my motion.
