V. Informational Reports

A. Budget Report (Eric presented Shana's report)

*Ms. Colleen and teachers have been working hard at getting the word out regarding supply fees. Currently we're at 63.1% for the whole school but I've also attached each classroom totals. We would like to personally congratulate Mr. Dyer's 6th grade class for achieving the 100% mark and Ms. Bennett's 8th grade class with 71.4%. Way to go!

Oasis ended October 26th and our final enrollment was tallied at 246 with credit of 244 students. (Oasis is determined based ion the average daily enrollment (in class on that day) for the month of October not registered students. See attached document for current enrollment for each grade.

Yesterday, ASD Budget sent out 2019-2020 budget based on estimated enrollment of 244. Budget did include state funding on line 4 of \$45,958 which has not yet been written into statute and not a guarantee. ASD would like us to use our own discretion when determining next year's budget and spending those funds. Our final budgeted amount for 2019-2020 is \$2,837,284. Principal Andersen and I will be using the provided budget amount as well as salary amounts that should be coming in the next couple of weeks from ASD to create a preliminary budget for the board. Teacher salaries are still unknown as well as benefit amounts. ASD will advise us in what would be the best estimate to use. The timing of a completed (draft) budget will be based on when ASD sends our needed information.

We are projecting approximately the same enrollment for next year.

B. Administrators Report:

*The faculty is working on a communication policy that will be sent out to the community on Monday and included in our parent handbook. A copy was emailed to the WCC members with this month's agenda.

C. Faculty: Julie Pepe-Phelps -

We are busy preparing for the Lantern Walk. We need more volunteers to hold the lanterns along the path. We also need more candles.

All of the classes are planning to make beeswax lanterns or candles in between Thanksgiving and holiday breaks.

We are still working on the Parent Handbook; planning to publish it in time for winter break.
