A. Administrator's Report (Julie Pepe-Phelps)

Ms. Pepe-Phelps gave the administrator's report. (attached) Questions about what kind of flexibility Winterberry will have once the school plan has been decided at the Tuesday school board meeting. It is not known at this time.

B. Faculty: (Sarah Glaser)

A few teachers attended online teacher trainings. The speaker advocated for technology for all grades during this time. "We need to see the technology as a life raft and not be afraid to use it." Another focus of the training was in regards to providing an anti-racist education. Molly Towner gave a presentation in the spring about cultural responsiveness. She hopes that this is something the whole staff will continue to take up.

Some members of the faculty have wondered what kind of freedom Winterberry will have to make decisions.

C. WPG Report (Jessie Menkens)

WPG did not meet last month, but will meet next month. Jessie will continue to serve as the WCC/WPG Liaison. Trina McBride was elected as the new treasurer. Barbara Amy, the past treasurer, will be missed. Jessica Gardner (fundraising) and Oona Martin (president) will stay on into the fall for a transitionary period. There will be a visioning process coming soon. They hope to include participation from all 3 bodies. A lot of money was saved because the teachers did online trainings this summer. VI. Business

A. Winterberry's response to school start

What is the WCC role as a board? First and foremost to support the principal, the well being of the school, and the charter.

One of WCC's roles is health and safety.

Questions about homeschool or Hybrid vs. online vs. in-person. If a student is homeschooled, do they lose their spot?

Julie- would like to be as generous/flexible as possible, while also being fiscally responsible.

Sue- Would like to see lots of communication to families, even if the communication is to say "We don't have answers yet." Maintaining the safety and fidelity of our model.

Lisa- What role can this play in making sure Winterberry is offering high quality Waldorf Education? We have a model for delivering our curriculum online. What role can the WCC play in supporting this?

Sarah- Would like to see us pursue the question of whether we can be more restrictive than the district safety-wise. The first step is advocating for that power for our school.

Lisa- Distance education full- time saves the inconsistencies of flip – flopping from distance/hybrid.

Jessie- suggests a meeting with Dr. Bishop, Ms. Pepe, some members of WCC on that topic.

Sarah- Has not seen the numbers the district plans to use (what percentage of transmission over how many days?) for movement from one realm to another.

Julie-Initial plan was to see what the school board decides on Tuesday and then meet with any faculty who wants to meet next week. Everything that has been offered so far has been a draft.

Sue: There's a finite window of opportunity we have in front of us. She would like to find out sooner rather than later

Paula: It seems essential to find out ASAP if a charter school principal can opt out of reopening a school during a pandemic. What is the most efficient/fastest way to find that out? Julie: is happy to ask those questions of Darrell or Dr. Bishop. He did not have answers to the questions asked today.

Sue suggests a committee meeting including Julie, a faculty member, and at least some WCC members OR call an emergency meeting next week.

Sue suggests asking WPG reps to contact the families in their class to ask questions about how the families are feeling. Faculty needs to be surveyed also.

Alex- The WCC needs to make sure to follow the open meetings act and trusts Ms. Pepe to handle this.

Jessie- Should the Tuesday evening board meeting be announced to the community?

Susannah- hopes the board can be open to an emergency meeting as needed in the next few weeks.
