- A. Budget Report Lottery July 27 (2<sup>nd</sup>). Numbers will change. Attached report with waiting list numbers. Only 8<sup>th</sup> grade is not full (26). Need to wait until Coleen comes back to get the correct numbers. Hybrid numbers are attached. Waiting on accurate numbers for hybrid. Need 10 students to break even for the program.
- B. Administrator's Report-Welcome Eric Andersen! First day on the job. Priorities: Feels supported and has contact with teachers. 1. Hiring need to finalize. Will get coached to get through hiring (3<sup>rd</sup> grade, Kindergarten TA, SPED TA, Handwork TA). 2. Scheduling -Julie has been helping. 3. Working on a newsletter wants as much communication as possible. Goal is to have a monthly newsletter that includes important and upcoming events. Will get staff input. 4. Get familiar with student files. Tara asked about movement teacher not pink slipped. There will be two fulltime SPED TA's and one full time SPED teacher. Maria applauds Mr. Anderson's emphasis on communication. Tara stated the Winterberry website has been switched over to ASD Shanna and Alicia need to make corrections.
- C. Faculty Report NA no faculty. Some are at training
- D. WPG Report Crystal V. is WPG president. Craig and Lynn had his last meeting in May. Working on WEP program. WEP was hired through school district, but then was not able to. WPG took it on by hiring an administrator. However, the administrator changed several times and had some hiccups. WEP is now looking at outsourcing. Julie may have applied for a state certification for childcare. A committee was formed. Anchorage Waldorf has child care, but there would need to be transportation. The kindercare would continue. Goal is to have the child care be it's own entity. There are also space issues at Winterberry. Concern is that the parents need childcare to be able to attend Winterberry. Enrollment needed to break even is 14 children. Julie is certified as the administrator and would help if needed. Allocated \$21,231 for teacher training. Ms. Robaxiou did not get fully funded. Mr. Lind was not able to attend. Filter and vents needed maintenance. Interier painting is going for bid. Water filters need to be replaced monthly and is costly at \$70 a month per class. Considering taking the filters out.
