Notes from Part I, Observations (November):

Board Observations:

- Mean data above state and district
- Surprised, both better than I thought
- So few students, expected spread between proficient and advanced
- Covid Bubble
- Clarification on arrows
- Better score, but be worse, higher #=worse?
- Content spirals
- Levels vs. grade levels
- Grade level growth from 7th to 8th

Some shared wonderings/inferences instead of observations:

- 8/9 performed better, new to system, start to get the hang of it
- Students that stick with us, are they better off? Turnovers?

January Inferences:

- -Data suggests 1) HACS attracting stronger math students or 2) attracting regular math students but not developing them as well
- -6th graders must have been already high in math from last year
- -it is difficult to make a good inference from just this score report. Could pulling more complexity of data sample, other tools, support better inferences?
- -The data indicates the median is only 1% lower than the district, and 2% better than the state. Looking at the middle show consistency with the district.

Our math class are by academic levels and not be grade level. AK Star is a grade level test. We are seeing many students coming to Highland who come in with lower math scores on MAP and we place them in lower than "expected" grade level class.

Our math curriculum follows vertical looping and repeating of categories like stats and probability, geometry, and other areas that aren't necessarily shosing up on the AK Star test (depending on the grade level)

The math is concerningand I'm wondering if it picks up in 10-12 grade or if our methods as described above aren't as productive? Or if we are getting students who start at a lower point in time?

My sense is that Highland is attracting students with low math skills at present. I don't think this is bad but it DOES seem to be a fact we need to address
