Mo Matua/Matua Tausi Fanau:

E mana'omia e tamaiti ona a'oa'o mo le soifua maloloina o mea'ai. E ofoina e le **Anchorage School District** mea'ai mo le soifua maloloina i aso ā'oga uma. E \$4.00 le tau o le taumafataga o le taeao a le Elementary; E \$5.75 le tau o le taumafataga o le aoauli a le Elementary. E \$4.25 le tau o le taumafataga o le taeao a le Middle School; E \$6.25 le tau o le taumafataga o le aoauli a le Middle School. E \$4.50 le tau o le taumafataga o le taeao a le High School; E \$6.75 le tau o le taumafataga o le aoauli a le High School. O nei tau e aofia ai le toe totogiina o mea'ai ma e lē aofia ai mea la carte e pei o susu ma isi mea e fa'atau ese. E te lē tau tu'uina atu le fa'amatalaga, ae afai e te lē faia, e lē mafai ona matou talainā lou alo mo mea'ai fua pe fa'aititia le tau. E tatau ona aofia ai le numera saogalemu a le tagata matua o le āīga o lo'o ia sainia le talosaga. E le mana'omia le numera o le saogalemu pe a e talosaga e fai ma sui o se tamaititi tausī pe e te lisiina se Supplemental Nutrition Assistance Program (SNAP), Temporary Assistance for Needy Families (TANF) po'o Food Distribution Program on Indian Reservations (FDPIR) numera mataupu po'o isi fa'ailoga FDPIR mo lou alo po'o le taimi e te fa'ailoa ai o le tagata matua o le āīga o lo'o sainia le talosaga e leai sana numera saogalemu.
