#### Note from the Principal

Dear Girdwood PK-8 Families,

The fall colors are here and the snow is slowing moving down the mountain with many of us anticipating a snow filled winter to enjoy the various outdoor activities we all enjoy to stay happy and healthy! The Girdwood PK-8 School community is incredibly tight-knit, passionate, and resilient. Those traits are the very things we need to focus on as we navigate a school year that is starting just as non-traditionally as the last one ended. We must be ready for changes along the way that do not occur in a "normal" school year and I appreciate all of your flexibility. Our students' participation in the ASD In-School Blended Learning model and ASD Virtual shows that our students and their families value education. We know that we have all experienced some "bumps" along the way, but that our students, parents, teachers, and our community are learning new ways to expand our thinking and we are growing stronger together.

Our students spent the first few weeks of school making connections and getting to know their classmates. Now teachers are diving into the content areas of math and language arts, also touching on social studies and science. While we do not have the specialist classes: health, music, art, library, and PE, we hope as a family you are still able to explore the learning activities found on your student's Canvas account to ensure the development of the whole child. Almost all of our students, K-8, completed the iReady diagnostic assessment which is quite impressive. We truly appreciate all of your help in ensuring your child completed the iReady assessment at home.

You should have all received an email from ASD Superintendent, Dr. Bishop, with an overview of the district's reentry plan with the revised matrix for school start in the building. Our district has a re-entry task force with many work groups who are continuing to work together to make the best decisions for our school and community. Here at Girdwood School, we have been actively planning and practicing safety protocols since our front office staff returned to the school building in mid July and our teaching staff returned in early August. Details about what a safe return to the building looks like will be shared by ASD, as well as in correspondence from our school, as the information becomes available. I feel optimistic about the idea of our students returning and want you to know we will lead with safety as our priority to create the safest learning environment for our students possible!

In closing, I want to thank you for your continued support and wish you and your family good health! I feel confident that when we all return together, it will be with a greater sense of belonging and a renewed perspective on all of the values that make Girdwood PK-8 School such a special place. We consider your children our children as we plan for their safe return. If you have any questions or concerns, please don't hesitate to give us a call. We appreciate our families immensely!



**Overdue Books Notices!!** It is time to return books to the library that you may have had out since last school year. When COVID shut down our schools so did the book return. It is important that we get our books back as we have hundreds of books missing. Each book costs anywhere from \$5.00-\$40.00 and the costs are enormous for replacement. Please search your homes for any books that are barcoded with Girdwood School on the back or have a spine label. We appreciate your help in returning our school resources. Notices will be going home with students missing library books soon. Thank you for your help.

#### **Gaggle Cybersecurity Software**

With the onset of online learning across the District, ASD has an obligation to ensure that students are not accessing or exposed to inappropriate content or engaging in any destructive online behavior when using the District network or computers. In an effort to keep students safe from potentially harmful online activity, ASD monitors all activity through all Google applications for any content related to:

- · Drugs & Alcohol
- · Harassment
- · Nudity & Sexual Content
- · Profanity & Vulgar Language
- Suicide & Self Harm
- · Violence Towards Others

This monitoring process screens documents generated by, shared by, or shared to students via Google Drive, which includes documents that may be submitted via Google Classroom. These documents include but are not limited to Google Suite and Microsoft Office documents, spreadsheets, and presentations, as well as a variety of image file formats. When questionable content is identified, it is flagged and a report is forwarded to school administrators, who will in turn notify parents or guardians. Again, the focus here is maintaining a safe and healthy online learning environment for all of our students.

Schools have always borne the responsibility of monitoring students' school-related work and communication. Given that all instruction, communication and work submission is web-based, this safety check has taken on a new form. All monitoring follows the strict guidelines of the Family Educational Rights and Privacy Act (FERPA), which safeguards sensitive student information. The District takes staff, student, and family confidentiality very seriously and has robust systems in place to ensure that information is not released in an unauthorized manner.

#### SEPTEMBER 2020 NURSE NOTES

Welcome back! Nurse Summer and Raquel look forward to helping keep all of your children safe and healthy at school when students return to the building. We are all well aware that 20/21 is off to an unusual start. There are changes to school routines and how things look in classrooms. What it looks like for students when they have even a runny nose will be different this year too. We are here to support you through all of this!

The information we know now about Covid-19 has informed us in our planning and preparing for school start. As we learn more we will adapt to best serve our Girdwood pK-8 families. One significant change is the guidelines for "when to stay home from school." We will send out more specific information as we near students returning to school.

Generally, if your child has a symptom that could possibly be due to Covid-19 we will ask you to keep your child at home. If your child develops symptoms at school we will ask you to pick them up. We will work with you so you know how long to stay home and where you can obtain testing if needed.

We expect that students with any symptoms of illness will be out of school for greater lengths of time than years past. We understand that this will be challenging for families. This is where we all come together, to do the best we can, to protect all of our families and our staff from spreading Covid-19.

Lastly, please get your annual flu shot! We will be giving free routine and flu vaccines this Wednesday the 30th at the ASD Ed Center in Anchorage. The Girdwood Health Clinic will have free drive through flu shot clinics in October and offers routine required immunizations by appointment.



## Who should NOT wear masks?

**Health Services Department** 

- Children younger than 2 years of age
- People with baseline trouble breathing
- Anyone who cannot remove the mask in case of medical emergency
- Those intolerant due to developmental disabilities, mental health issues, or sensory sensitivities
- Severe asthma, requiring frequent emergency care/hospitalization

## MYTHS about Mask Wearing...FALSE!

- Masks decrease oxygenation.
- Masks increase carbon dioxide.
- Masks are not effective.
- Masking means you don't need to physically distance or avoid crowds.

## TIPS for Success in Mask Wearing

- Educate about oxygen & CO2 normality with a mask
- Have children practice proper mask wearing at home and at school
- Consider fun mask designs
- Role model mask wearing, avoiding touching the face, hand washing & physical distancing
- Keep asthma under control
- Consider clear face shields for hearing impaired communication

## **CDC and WHO Recommendations**

The CDC and the World Health Organization (WHO) both recommend wearing masks or fabric face coverings in public spaces where you can't keep a proper distance from other people. The American Academy of Pediatrics recommends that "Elementary students should wear face coverings if the risk of touching their mouth or nose is not greater than the benefit of reducing the spread of COVID-19. When possible, spacing desks 3 to 6 feet apart and using cohort classes and outdoor space, is recommended The Anchorage School District is requiring a face mask for anyone entering their facilities including students, teachers, staff and parents.

## **Masks and Health Issues**

A limited number of people with asthma and respiratory issues may experience discomfort or have trouble breathing while wearing a face covering.

"For people with very mild asthma or well-controlled asthma, it's probably not going to be an issue," said Dr. David Stukus, member of the Medical Scientific Council for the Asthma and Allergy Foundation of America (AAFA). "For people who have very severe disease and have frequent exacerbations, ER visits, hospitalizations, require lots of medications and frequent symptoms, it might cause more issues for those folks."

It's important to keep a child's asthma under control to prevent exacerbations. Remind parents and patients to use medications as prescribed. If they are having breathing issues more than two times per week, they may need a control medication, a dosage change or a medication change. Remind parents to keep children home if they start having significant asthma symptoms.

Children with disabilities may also experience issues with mask wearing. According to the CDC:

- People who are deaf or hard of hearing—or those who care for or interact with a person
  who is hearing impaired—may be unable to wear cloth face coverings if they rely on
  lipreading to communicate. In this situation, consider using a clear face covering. If a
  clear face covering isn't available, consider whether you can use written communication,
  use closed captioning, or decrease background noise to make communication possible
  while wearing a cloth face covering that blocks your lips.
- Some people, such as people with intellectual and developmental disabilities, mental
  health conditions or other sensory sensitivities, may have challenges wearing a cloth
  face covering. They should consult with their healthcare provider for advice about
  wearing cloth face coverings.

## **Working Together**

Students and families need to work together to keep their school community safe. If a child or teen is having trouble wearing a mask, recommend trying a different fabric or fit. You may have to do some "myth busting" and remind parents that according to the WHO, medical masks when worn the right way do not cause individuals to breathe in more carbon dioxide or reduce oxygen levels. While a face mask or covering may just be uncomfortable, this can be distressing

to parents and children. Recommend coverings made from fabrics like 100% cotton T-shirt material. They may have to try a selection of mask types to find the right type for their child.

When appropriate and possible, we urge Pediatricians to try to work with parents to find solutions to mask issues rather than issue letters of exemption in an effort to keep Covid-19 out of our schools.

Does	s the rest of my household need to quarantine or get tested?
	No. Only the person who was a close contact with the positive case needs to quarantine.
Can	the student's sibling go to school?
	Yes.
Who	was the person? What was the exposure?
	For privacy reasons, we cannot share any details other than that your child and all others who were in contact with the positive case need to be quarantined for 14 days.
The s	student needs to do sports/activity outside the home. Can they do that?
	The student may not leave your home for any reason for the next 14 days, except to seek medical care for COVID-19 or to go outside for exercise if they can remain 10 feet away from others.
Wha	t if the student gets sick/sicker?
	Call the student's doctor for advice. Do not go to the doctor's office before calling. They need to know that the student is under quarantine so they can prepare. If the student has emergency symptoms like difficulty breathing, turning blue, seeming confused or passing out, call 911.


