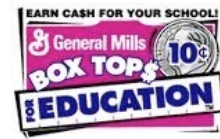

## ATTENDANCE POLICY

Below are the basic guidelines for reporting a student's absence: If your child will not be at school, please call the school office at 742-5300, or email Bethanie and Robyn, **before** 10:30 am, to excuse their absence. Please make sure you call the office, even if you have told their teacher.

If you know in advance of a scheduled absence, please call the office and send a note to the classroom teacher ASAP.

This will help the teacher to gather schoolwork, if needed. If your child will be gone for more than a couple of days, please fill out the extended absence form. You can get one in the office. Tardy students must stop in the office, sign in, and get a late pass, before going to class.

If parents want their child to ride a different bus home or get off at a different bus stop, they must send a note for the bus driver and have it signed by the office.

Parents picking up students before the end of the school day must come to the office to sign them out. We will call them down from their classroom when the parent gets here.

## VOLUNTEER WAIVER & RELEASE

2. I understand that participation in the Activity involves certain inherent risks and dangers. These inherent risks may include (without limitation) uneven surfaces, lifting, slippery surfaces, dangerous tools and instruments: working in a small confined space; my own negligence; and the negligence of others. These inherent risks may result in trips/falls; fatigue; injury; significant injury/disability; and even death. I have made my own investigation of the risks of participation in the Activity, and I understand these risks and assume them willingly on behalf of myself and each and every one of my heirs, representatives, executors, administrators, and assigns. I acknowledge that I AM ULTIMATELY RESPONSIBLE for my own safety during the Activity.
3. ON BEHALF OF MYSELF AND EACH AND EVERY ONE OF MY HEIRS, REPRESENTATIVES, EXECUTORS, ADMINISTRATORS, AND ASSIGNS, I UNEQUIVOCALLY AND VOLUNTARILY ASSUME ALL RISKS RELATED TO PARTICIPATING IN THE ACTIVITY, INCLUDING BUT NOT LIMITED TO THE RISKS IDENTIFIED IN SECTION 2, ABOVE, THAT MAY ARISE OUT OF OR PERTAIN TO MY PARTICIPATION IN THE ACTIVITY.
4. ON BEHALF OF MYSELF AND EACH AND EVERY ONE OF MY HEIRS, REPRESENTATIVES, EXECUTORS, ADMINISTRATORS, AND ASSIGNS, TO THE FULLEST EXTENT PERMITTED BY LAW, I AGREE TO FOREVER RELEASE, INDEMNIFY, AND HOLD THE DISTRICT HARMLESS FROM ANY CLAIMS OR CAUSES OF ACTIONS (WHETHER SOUNDING IN TORT [NEGLIGENCE, NEGLIGENT HIRING/TRAINING/SUPERVISION, WRONGFUL DEATH, OR OTHERWISE], DEMANDS, OR EXPENSES (INCLUDING, BUT NOT LIMITED TO, ATTORNEY'S FEES AND COSTS) OF ANY KIND OR NATURE WHATSOEVER THAT IN ANY WAY ARISE OUT OF, RESULT FROM, OR PERTAIN TO MY PARTICIPATION IN THE ACTIVITY.
5. Should the District, or anyone acting on its behalf, incur attorney's fees and/or costs to enforce the terms of this Agreement, or to defend any claims brought contrary to this Agreement, I hereby agree to indemnify and hold the District harmless for (in other words, I agree to pay for) any and all such attorney's fees and/or costs.

**Warning:** This agreement is a binding contract that prevents you and your collective heirs, representatives, executors, administrators, and assigns from bringing any lawsuit against the District arising out of or pertaining to my participation in the Activity, including but not limited to any negligence claims. This document affects your substantial legal rights and remedies. Please read it carefully before proceeding.

FULLY UNDERSTANDING ALL OF THE ABOVE, AND WITH REASONABLE TIME TO READ AND UNDERSTAND THIS AGREEMENT AND TO OBTAIN ASSISTANCE IN DOING SO, I UNEQUIVOCALLY AGREE TO THE TERMS OF THIS AGREEMENT.

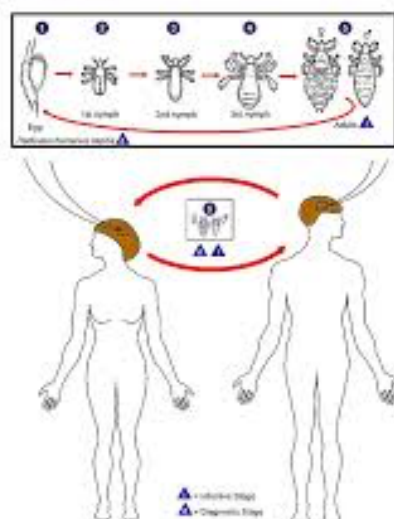

## Lice

Lice is an ever present nuisance. Inform nurse Raquel or Summer if you find head lice on your child so that we can check close contacts and promptly address the problem.

## Flu Season &amp; Other Contagious Illnesses

It's that time of year...

Please keep your child home if they are sick (see the Should My Child Stay Home? Guidelines for Deciding handout).

Teach your child to cover their coughs and sneezes with a tissue or cough/sneeze into your sleeve.

Wash hands! Warm, soapy water is best and hand sanitizer is best if water is not available.

Discourage your child from touching their eyes, mouth or nose.

## SHOULD MY CHILD STAY HOME? GUIDELINES FOR DECIDING

**FEVER** A fever is a warning that the body is fighting an infection that could easily spread to others. A child with a temperature of 101 F should not be sent to school; s/he should stay home until fever free without the use of fever reducing medications like Tylenol.

**COLDS** Are more difficult to assess. A slightly runny nose and occasional dry cough is not enough to keep your child home. However, if your child's nose runs constantly and/or the cough is frequent and wet, or your child is experiencing nausea or is too tired and uncomfortable to function at school it would be best to keep the child home for a day or two.

**COUGH** If your child has a severe cough, rapid and/or difficult breathing, wheezing, or bluish tint to the skin or the cough is accompanied by a sore throat or not feeling well, the child should stay home from school.

**DIARRHEA** This is defined as an unusual amount of very liquid stools compared to the child's normal pattern. Child should stay home until able to participate normally at school.

**EARS** If the child has pain, swelling, drainage or difficulty hearing; please see your healthcare provider. Untreated ear infections can cause temporary or permanent hearing loss.

**EYES** Red, itchy eyes with a clear, yellow or green drainage from the eye may be contagious and a sign of bacterial conjunctivitis (pink eye). A child with pink eye can attend

school as long as they are able to keep from touching their eyes and show that they can properly wash hands after contact with the infected eye.

**MEDICATIONS** The school district has very specific rules for all medications in school including cough drops. Please see the School Nurse if your child requires any medications while at school.

**RASH** A rash might be the first sign of an illness. If your child has a rash with a fever and behavioral changes, or a rash that is oozing/ open wound, or is tender with the rash worsening, s/he should be evaluated by a healthcare provider.

**SORE THROAT** If your child has a sore throat, have the child gargle with warm salt water. If his/her behavior is normal and the child ate breakfast, it's probably safe to send him/her to

school. If the child has difficulty swallowing, or you notice saliva building up in the child's mouth because s/he can't swallow, please keep the child home. If you notice white spots seen in the back of the throat please contact your doctor, this could be a sign of an infection.

**VOMITING / NAUSEA** Please keep your child home if he or she has vomited more than 2 times in 24 hours or also has a fever or if s/he looks or acts ill.

- Student Booths are available for students in grades K-8 for \$10. These booths are intended for students to sell their own hand-crafted items and limited to a 5' x 5' space, students must provide own table.
- No more than two exhibitors may share a space. (If Sharing a booth space, both vendors must submit their own application and specify if sharing a space)
- Electrical access is limited. Vendors will need to bring their own extension cords.
- Deadline for entry is Saturday, November 24th.
- Vendors set up 9-11am Saturday morning. All vehicles must be out of the unloading zone by 11:00am. Break down is no earlier than 6pm.

## ASD Statement of Nondiscrimination

### **Board policy 114 Nondiscrimination & Harassment**

The Board is committed to an environment of nondiscrimination on the basis of race, color, religion, sex, age, national origin, economic status, union affiliation, disability and other human differences. ### **Board policy 114.1 Inappropriate Behavior**

The Anchorage School District supports respectful learning and working environments and believes strongly this environment must be structured to reflect diverse cultural traditions and contributions. The District values diversity among students and staff and believes that all students and staff have the right to participate in school activities free from harassment. Behavior by Board members, administrators, employees, parents, volunteers, students, vendors, or others doing business with the District, that ridicules, harasses, intimidates, or threatens students, staff or community members, or otherwise undermines a respectful safe, and effective school environment, is prohibited. Individuals or groups are in violation of this policy if they engage in any of the above behaviors in a way that is disruptive to the work or education environment, such as:

- Making demeaning remarks directly or indirectly such as name-calling, racial slurs or “jokes”; or
- Physically threatening or harming an individual; or
- Displaying demeaning visual or written materials; or
- Defacing, damaging, or destroying property or materials; or
- Performing any other act that is clearly harassing in nature.

Any student, staff, or community member who believes that he or she has been the subject of harassment and/or discriminatory behavior should report the incident immediately to the principal or department supervisor. Complaints regarding harassment/discriminatory behavior will be investigated immediately.

Any student, staff, or community member who violates this policy will be subject to appropriate disciplinary action.
