Fall Assessments

Map Growth

2024-2025

MAP Growth is the ASD and State of Alaska required benchmark/interim reading and mathematics assessment for students in grades 3-9. Grades 10-12 students identified as needing Tier II and Tier III reading and mathematics support also take MAP Growth as part of the Anchorage School District's MTSS framework.

Alaska's Department of Education and Early Development (DEED) has partnered with NWEA to implement a creative approach to a balanced statewide assessment that connects fall and winter MAP Growth benchmark/interim assessments and the Alaska spring AK STAR summative assessment. AK STAR eliminates the spring benchmark/interim assessment window for grades 3-9 by combining the summative and benchmark assessment into one test that produces a spring benchmark score, which includes a growth measure. More information is available at the State of Alaska AK STAR website, education.alaska.gov/assessments/akstar.

MAP Growth is an online, adaptive assessment that provides each student a personalized testing experience with data that speaks to their individual progress and growth in mathematics and

reading.

The MAP Growth reading and mathematics benchmark will be administered in person during the 2024-2025 fall and winter benchmark windows. The spring benchmark will be embedded in the AK STAR summative assessment as outlined above.

- Fall Benchmark 1: September 3 - September 13 (make-ups through September 20)
- Winter Benchmark 2: December 2 - December 13 (make-ups through December 19)
- Spring Benchmark 3: embedded in AK STAR administered during the summative assessment window: March 24 - April 4 (make-ups through April 25)
 - MAP Growth assessment only: Grades 10-12 identified as needing Tier II and III support

MAP Growth practice tests and tutorials allow students and families the opportunity to become familiar with the types of questions and tools available on the actual MAP Growth assessments such as the highlighter and calculator. 2024 - 2025

As part of The Alaska Reads Act, the State of Alaska requires that districts administer an early literacy screening tool three times a year to students in grades K-3 to identify potential reading difficulties in order to improve reading outcomes for students. Families can read more about this comprehensive K-3 reading policy at The Alaska Reads Act website: education.alaska.gov/akreads

mClass with DIBELS 8th Edition Assessments is the State of Alaska Department of Education's and ASD's Early Literacy benchmark screening and progress monitoring tool for students in grades K-3 in reading. mClass utilizes curriculum-based measures and is used by schools as part of the ASD Comprehensive Assessment System to support informed instructional decisions.


Counselor Notes

My name is Alisa Drake, and I am your child's School Counselor. A few things about me ...

- I was born and raised here in Anchorage

- I've been married 21 years and I have three pretty awesome sons
- I love getting out in the woods and on the water to hunt, fish and trap with my family
- And I truly love my job as Kincaid's school counselor!



What do I do as a school counselor?

- I am here to help every single student be as successful as they can and discover their potential!
- I teach classroom lessons (K-5th) every other week. Topics include things such as, Integrity, Compassion, Courage, Conflict Resolution, Growth Mindset, Kindness, UpStanding (Anti-Bullying), and more!
- I also offer one-on-one support for any students who might benefit from doing so. Students often see me for individual counseling to work on decision-making, anger management, family changes, friendship skills, or another concerns. Both teachers and/or parents can refer students to me, and students are also able to self-refer and request to see me (There is a purple box in the front office where students can place their request to see me).
- I also offer small groups to help improve friendships, increase attendance, process grief, and/or any other focus that would benefit our students and our school community. Small groups are generally 6-8 sessions and are offered during lunch and/or recess. A signed permission slip will be needed from parents/guardians if your student has been identified as a potential small group member.




Nurse Notes

Since June, 91 cases of pertussis have been reported to the Alaska Section of Epidemiology. This represents a marked increase in pertussis activity this year compared to recent years and mirrors a trend occurring throughout the United States. Most of Alaska's reported cases have occurred in the Southcentral region. Note: There has also been sustained respiratory illness activity associated with viral infections this summer see:

Dear Parent(s)/Guardian(s),

This letter is to let you know that your child's class will be receiving age-appropriate lessons on child sexual abuse and assault prevention education as required under the state's [Alaska Safe Children's Act \(Erin's Law\)](#).

Erin's Law Education is comprised of two lessons (one lesson at the beginning of each semester) taught during the Health classes. Combined, these lessons meet the full requirements for students under the [Alaska Safe Children's Act \(Erin's Law\)](#) and are designed to help prevent childhood sexual abuse. These lessons will be presented in a non-threatening way, along with the skills needed for self-protection and will be handled in a sensitive, respectful manner.
