ASD is responsible for identifying and determining if students, who have had the influence of a language other than English in their background, qualify for the ELL program. Your student's most recent English language proficiency assessment indicates that they continue to meet the criteria for the program. Their overall score from this assessment is marked above. Below is information regarding our ELL program's support models. The Anchorage School District is committed to the success of all students through the implementation of the Multi-Tiered System of Supports model ([MTSS](#)).

- Tier I:** English Language Arts curriculum designed in collaboration with the ELL Program to facilitate the acquisition of advanced language and literacy by end of 5th grade. ELL Elementary Lead Teachers work closely with site-based instructional coaches and district literacy leads to support districtwide implementation of language and literacy practices most conducive to English language development.
- Tiers II and III:** ELL site resource teachers and paraprofessionals, in collaboration with ELL Elementary Lead Teachers and literacy leads, perform a direct role in implementation of Tier II and Tier III supports targeted to advance academic language and literacy acquisition for English Learners.
